RESOLUTION MODIFYING THE BUILDING & ZONING FEE SCHEDULES

WHEREAS, The Board of Preble County Commissioners have concluded that the current building and zoning fee schedules are insufficient for the operation of the Preble County Building Inspection and Zoning Department; and,

WHEREAS, The last amendment to the current building and zoning fee schedule was October 20, 2010; and,

WHEREAS, After a review of the current building and zoning fee schedules it has been determined that the current fee schedule needs to be amended in order to efficiently and effectively operate each department; and,

WHEREAS, Public hearings were held on November 14, 2011 and November 16, 2011 on the proposed amendments; therefore, be it

RESOLVED, That the Board of Preble County Commissioners does hereby modify the current Building & Zoning Fee Schedules to be effective January 1, 2012 as follows:
