

## NOTICE TO CONTRACTOR

The County of Preble through its Board of County Commissioners, will receive sealed proposals for the following in the Village of College Corner:

**GENERAL DESCRIPTION:** Eaton Street Improvements and Waterline Upgrades Project

Install approximately 2,000 feet of new 8" PVC waterline along Eaton Street, from County Line Street to Indiana Street, including connecting to all intersecting waterline mains. Fire hydrants to be relocated or replaced. Water service lines, meters and pits will also be replaced with new. Remove and replace curb and walk and widen street from County Line Street to Indiana Street. Repair existing pavement, plane existing pavement to improve cross slope, and overlay entire width with new asphalt pavement.

A **Pre-Bid Conference will be held at 9:00 a.m. local time on Tuesday, July 17, 2018.** The Pre-Bid meeting will be held on-site, located at the south end of Eaton Street, at County Line Street, in the Village of College Corner, Ohio, 45003. **Attendance at the Pre-Bid Meeting is Mandatory.**

**Sealed Bids will be received until Wednesday, July 25, 2018 at 11:00 a.m., local time,** at the Office of the Board of Preble County Commissioners, 101 East Main Street, Eaton, Ohio, 45320, at which time and place they will be publicly opened and read aloud.

Copies of the Plans and Specifications, the estimated quantities of the items of work, the proposal and the contract forms are on file in the Office of the Board of Preble County Commissioners where they may be obtained upon the payment of \$75.00, none of which will be refunded. An additional non-refundable handling charge of \$10.00 per set is required, if documents are to be shipped. Checks shall be made payable to Kramer & Associates, LLC. Proposals will only be accepted from bidders who have obtained Contract Documents (including plans and specifications) and have been registered as a plan holder with the Board of Preble County Commissioners. Each proposal shall be signed by the full name and business address of each person or company interested in the same, and shall be accompanied by a surety bond by a bonding company authorized to do business in the State of Ohio or by a certified check or cashier's check from some solvent bank. The bid guarantee bond shall be for the full amount of the bid and the certified check or cashier's check shall be equal to ten (10%) percent of the amount of the submitted proposal. The surety bond, certified check or cashier's check shall be payable to the Board of Preble County Commissioners as a guarantee that if the proposal is accepted, a Contract will be entered into and its performance properly secured by a satisfactory bond in the amount of one hundred (100%) percent of the contract price. All provisions of the Ohio Revised Code as it relates to bid guarantees, conditions, liabilities and withdrawal of a bid shall be adhered to by the Contractor.

The proposal must be made on the forms provided in the contract documents, or a copy thereof, with a price quoted for the work.

This project must use the Federal Davis Bacon wages included with the bid packet.
